## Campus Security Annual Report

### Clery Overview

The backlash against unreported crimes on numerous campuses across the country led to the Jeanne Clery Disclosure of Campus Security policy and Campus Crime Statistics Act. The Clery Act, signed in 1990 was originally known as the Crime Awareness and Campus Security Act. The law was amended in 1992 to add a requirement that schools afford the victims of campus sexual assaults certain basic rights, and was amended again in 1998 to expand the reporting requirements. The 1998 amendments also formally named the law in memory of Jeanne Clery, a 19-year old Lehigh University freshman who was raped and murdered in her campus residence hall in 1986. Subsequent amendments in 2000 and 2008 added provisions dealing with registered sex offender notification and campus emergency response. The 2008 amendments also added a provision to protect crime victims, “whistleblowers”, and others against retaliation. It was most recently amended by the Violence Against Women Reauthorization Act of 2013 (VAWA) enacted March 7, 2013.

(The Clery Act) is a federal law that requires colleges and universities to disclose certain timely and annual information about campus crime and security policies. All post-secondary public and private institutions participating in federal student aid programs must adhere to these regulations. To ensure compliance with the Clery Act Tennessee Academy of Cosmetology must meet certain obligations required by federal law. These obligations include: 1. Policy disclosure; 2. Records collection and retention; 3. Information dissemination.

### Policy Disclosure

Tennessee Academy of Cosmetology must provide the campus community and the public with accurate statements of current policies and practices regarding procedures for students and others to report criminal actions or other emergencies on campus, security of and access to campus facilities.

It is TAC’s policy that students, faculty and staff are prohibited from engaging in, and are urged to report, any activities at the TAC campus or learning sites that threaten the safety and security of the TAC community, including: arson; assault; hate crimes; injury or illness; suspicious persons, abandoned vehicles or parcels; possession or sale of illegal drugs and other controlled substances; theft; robbery; threats; vandalism; and, any other violence or illegal activity.

**ALL URGENT OR EMERGENCY EVENTS SHOULD BE IMMEDIATELY REPORTED TO THE POLICE DEPARTMENT SERVICING THE LOCAL AREA. ALL URGENT OR EMERGENCY EVENTS CAN BE REPORTED BY DAILING 911 FROM ANY TELEPHONE ON CAMPUS.**

All such events should be also reported as soon as possible to available TAC staff and the designated TAC Campus Security Officer, Kevin Koch, at the TAC office at 901-382-9085. ## Records Collection and Retention

Tennessee Academy of Cosmetology is required to keep campus records of crimes reported on campus to law enforcement, and to make a reasonable good faith effort to obtain certain crime statistics from appropriate law enforcement agencies.

## Information Dissemination

To provide members of the campus community with information needed to make informed personal safety decisions, Tennessee Academy of Cosmetology must provide: 1. A “timely warning” of any Clery Act crime that represents an ongoing threat to the safety of students and employees. By texting and/or emailing; 2. Collect, classify and count crimes reports and crime statistics and; 3. Publish an annual security and fire safety report, make the report available to all current students and employees, and ensure the annual security and fire safety report is made available to prospective students and employees.
